The aim of the survey is to seek stakeholders' views and opinions on potential procurement reform in Wales. The survey will also touch on the UK Government's Green Paper proposals on procurement reform.

The UK's departure from the EU provides each of the UK's four Administrations with the opportunity to reform current procurement regulations.

This survey will help Welsh Ministers make a formal decision on a way forward for procurement reform in Wales in March 2021. Your views are important to us and once Welsh Government has gathered and analysed your feedback it will help inform this decision.

This offers an opportunity to further embed social partnership into ambitious public procurement rules.

Key to implementing will be social dialogue, adequate funding, skilling and training of workforce, social, environmental and labour protections, collective bargaining mechanisms.

Focus must also be given to the already agreed Code on Ethical Employment in Supply Chains. There is also an opportunity in Wales for procurement to strategically support the development of good quality jobs, training, and apprenticeships and economic development in turn supporting a Green, Equality based COVID recovery.

The policy context in Wales is one which prioritises social value, and this must run throughout our legislation, including procurement. It is up to Welsh Government to determine how procurement works within a devolved context and for the benefit of citizens in Wales, rather than procurement being determined by UK-wide legislation.

- [1] Corruption dishonest or fraudulent conduct by those involved in public procurement
- [2] Damages compensation awarded to an unsuccessful bidder in a flawed public procurement process

- [3] Automatic suspension if an unsuccessful bidder begins court proceedings before a contract is signed, it will automatically prevent the contracting authority from signing the contract with the winning organisation)
- [4] Redress remedy or compensation to aggrieved bidders who believe they have suffered harm because of breaches against regulations

- 1. Public procurement is a devolved regulation and must promote the fundamental right of democratic elected public bodies to deliver quality public services in the public interest, including through in-house services only.
- 2. Awarding contracts on a cost or price only criteria must be ruled out with a mandatory 'price-quality ratio' tendering process, giving sufficient weight to International (ILO) and UK social provisions, to prevent a UK 'race to the bottom'.
- 3. Tendering processes must be regulated, open, fair and transparent and subject to Freedom of Information (FOI) requests, with no emergency (crisis) exceptions or commercial sensitivity privacy clauses used to deviate from stringent regulations or prevent disclosure, particularly of labour costs, in order to serve the public interest.
- 4. Social value criteria must as a minimum promote, enforce and protect:
 - good work practices, fair pay, equality, trade union recognition and collective agreements and exclude companies which operate blacklisting of workers;
 - strategic use of public procurement in support of employment, training and apprenticeships for local economic development and inclusive growth;
 - enforcement of International and UK labour and human rights, due diligence, ethical procurement and environment criteria through both domestic and international supply chains of goods and services, incorporating joint and several liability;
 - GDPR standards for digitalisation and artificial intelligence in support of public service data ownership, data privacy rights, civil liberties, workers' digital rights and employer obligations to meet these standards.

A social contract approach must include the involvement of public service trade unions at all levels of public procurement decision making – from International agreements in the OECD and WTO, new global FTAs to domestic national, regional, local and workplaces to deliver the ambitious transformation that will benefit all.

- Pay and terms and conditions of employment for example, the foundation living wage rate should be identified as a minimum requirement for a valid procurement contract.
- There is no emphasis on modern slavery.
- Public procurement legislation must be at least equal to EU standards.
- Access to collective bargaining is a right ILO.
- The Green Paper doesn't address whether a service should or should not be put out to tender.
- Public bodies must be able to consider the complexities in coordinating hundreds of contracts – is this viable? What resource will be available to allow authorities to manage multiple contracts?
- · Process should not bypass proper scrutiny.
- Will health and social care be considered under separate public procurement policy?
